- Apply the national collective bargaining agreement to all employees in a complete and impartial manner, punctually paying the established remuneration and paying all the related social security, welfare and insurance contributions;
- Guarantee the protection of maternity and paternity, as well as disadvantaged people;
- Promote and improve the conditions of safety and physical and mental well-being of its collaborators with both preventive and corrective actions;
- Involve all suppliers of goods, activities and services and their commitment to social responsibility by complying with all the requirements of the reference standard;
- Develop and extend information, communication and training processes and promote dialogue with interested parties to ensure an efficient and effective application of the integrated company system;
